CONDITIONS OF PROBATION

You have been placed on probation by the Willoughby Municipal Court, this date, for a period of _____ months. You will report to your Probation Officer *as instructed*.

You are required to comply with the following conditions of probation:

1. You shall obey all local, state and federal laws. You must contact your probation officer immediately if you are arrested or questioned by any law enforcement agency. This includes all traffic citations.
2. You shall report as directed by your probation officer. You shall reply promptly to any communications from any member of the probation department. You are not to allow more than 60 days to lapse without communication between yourself and the probation department unless otherwise directed by your supervising officer.
3. You shall report the address at which you are actually living. If you change your address, phone number, and/or e-mail address, you must report that change immediately to your probation officer. The primary means of communication will be through e-mail, unless discussed differently with your supervising officer. **Your voicemail must be set up to accept messages.**
4. You shall not leave the State of Ohio without permission from the Court.
5. You shall not associate with any person (s) who are on probation, parole or with whom you previously violated the law. There may be exceptions to this Condition if discussed with your supervising officer in advance and put in writing.
6. You shall not use, possess, or have under your control, any controlled substance not prescribed to you by a licensed physician. Use of alcohol is prohibited.
7. You shall submit to random urinalysis as directed by the probation department. You shall not alter or tamper with your urine sample. Refusal or failure to provide a proper sample within 45 minutes will be treated as a violation of probation and handled accordingly. You must appear before 3:00 PM to submit to your screen.
8. You shall obtain and maintain employment in a lawful occupation. (Exceptions: Government issued Disability and/or Retirement Benefits or Pending Claims. You must also provide for the support of your dependents. You are to notify your probation officer of any changes in your work status.
9. You shall not use, possess, or have under your control, any firearm, dangerous ordinance, or deadly weapon, as defined by ORC Sec 2923.11.
10. You shall be assessed a minimum monthly supervision fee of \$20.00 per month. You shall pay all supervision fees, court costs, fines, and/or restitution as ordered by the Court.
11. Pursuant to O.R.C 2951.02, you are subject to a search of your person, residence, motor vehicle, and any other tangible personal property by a probation officer while on probation if a probation officer has responsible grounds to believe that you are not abiding by the law or are not complying with the terms and conditions of your probation.
12. You shall comply with all special conditions set forth by the Court. **These terms and conditions may be modified by the Court or your probation officer during the entire period of probation.**

I have read the above Rules of Probation. I understand that violating any of the Rules of Probation may result in my probation being revoked and the original sentence being imposed.

SPECIAL CONDITIONS: _____

I understand the Court may change the conditions of probation, reduce, or extend the period of probation. A violation of probation can result in reinstatement of any suspended fines, jail time, or other revision(s) ordered by this Court.

I hereby acknowledge receipt of a copy of the Conditions of Probation. I fully understand the conditions of my probation and will abide by them.
